1. This message rescinds MILPER message 19-040 and will expire one year from date published.
  2. The U.S. Army Recruiting Command (USAREC) is seeking qualified prior detailed recruiters to reclassify to military occupational specialty (MOS) 79R.
  3. The U.S. Army Human Resources Command (HRC) is accepting volunteer requests for previous detailed recruiters in the rank of SSG who hold special qualification identifier (SQI) 4 for reclassification into MOS 79R.
  4. Former recruiters who were removed from recruiting duty under paragraphs 5-4,

5-5, 5-6, or 5-12 of reference A above are not eligible for reclassification to MOS 79R.

5. Soldiers must meet these prerequisites for reclassification:

- a. Be in the rank of SSG (non-promotable) with SQI 4 and have successfully served a tour as a detailed recruiter.
- b. Meet MOS 79R prerequisites stated in reference D above.
- c. All Soldiers nominated/volunteering for Positions of Significant Trust (POSTA) must have an approved background screening.

6. Soldiers may request reclassification into MOS 79R regardless of the IN/OUT Calls of their MOS.

7. Reclassification processing procedures:

- a. SSGs interested in reclassification to MOS 79R must contact the USAREC Recruit-the-Recruiter team at [usarmy.knox.usarec.mbx.hq-g1-rtr@mail.mil](mailto:usarmy.knox.usarec.mbx.hq-g1-rtr@mail.mil) for assistance.
- b. The Recruit-the-Recruiter team will assist with the application process and provide an approval memorandum from USAREC to Soldiers accepted for reclassification into MOS 79R.
- c. Soldiers must take the approval memorandum to their unit Career Counselor to submit voluntary requests for reclassification to MOS 79R via the RETAIN system. Career Counselors will inform Soldiers if they qualify for monetary incentives related to reclassification, based on current policy. HRC is the final approval authority for all MOS reclassifications.
- d. Soldiers approved for reclassification by HRC will be scheduled to attend the Army Recruiter Course (ARC) in a temporary duty (TDY) and return status from their current unit, funded by USAREC. However, USAREC will waive the ARC training requirement for those Soldiers who completed a detailed recruiting tour within 12 months of the approved reclassification.
- e. Soldiers are awarded MOS 79R upon successful ARC completion or upon receiving a waiver for training from USAREC.

8. Soldiers who received a retention bonus for their current term of service will not be subject to recoupment due to this reclassification.
