Company Commander Letter of Recommendation (or applicable Company Grade UCMJ authority (USAREC Form 3.3) with email address, phone number and the following required statement :

"I CERTIFY THAT (NAME & RANK) SUCCESSFULLY PASSED THE ARMY PHYSICAL FITNESS TEST CONSISTING OF PUSH-UPS, SIT-UPS AND THE TWO MILE RUN WITH A SCORE OF (SCORE) ON (DATE); THE VERIFIED HEIGHT IS (FEET & INCHES) AND THE VERIFIED WEIGHT IS (LBS)."

ERB/ORB (Certified within 6 months of submission include most recent NCOES/OES level. No board brief)

Evaluations (All NCOERs/OERs and all AERs (1059s) in order newest to oldest)

Security clearance memorandum (Minimum Interim Secret/Interim Top Secret based on WO MOS)

College Transcript(s)* if applicable

Copies of Professional Certificates (Licenses or Certificates issued to Engineers, Mechanics, etc

GT score verification/REDD report (Sister Service Applicants and Education Office retests)

DA Form 7434-Application for US Army Marine Certification (880A, 881A)
