2. Warrant Officer Selection Board results for September 2024.

a. Q-S Fully Qualified Select:

1) The below named individuals were selected to attend the Warrant Officer Candidate School (WOCS). Applicants should expect to receive a notification via email with their WOCS class date from the Human Resources Command (HRC) within 90 days after selection.

2) Selectees can be removed by the applicant's commander for misconduct, loss of qualification or other disciplinary action per DA PAM 601-6, para 2-7a. Official request will be submitted through command channels to HRC. HRC requires a DA Form 4187 signed by a Company CDR level. 3) Selectees must hand carry a copy of their security clearance verification and all approved waivers (Medical/APFT/Moral/AFS/Age/tattoos) when they report to Fort Novosel. All Candidates will hand carry HQ USAREC Form 3.1 (Results of Medical Examination) in lieu of the approved DD Form 2808. If a waiver is required, you must provide a copy of the approved waiver. If you don't have a USAREC Form 3.1, take your DD Form 2808 to school. The Results of Medical Examination must be no more than 24 months old from the date signed by the examining physician through the projected WOCS graduation date for technical MOS candidates, and 18 months for aviation candidates (150A and 153A). Candidates possessing physicals, clearances or waivers that do not cover scheduled training attendance at WOCS may not be able to enroll in the program. If you have any tattoos, ensure that they are in compliance with AR 670-1, para 3-3 and DA PAM 670-1, para 3-3.

4) Personnel identified with an asterisk (\*) are required to take and pass the Occupational Physical Assessment Test (OPAT) prior to reporting to WOCS per HQDA EXORD 071-17 and TRADOC TASKORD IN 163641.

a. Q-S (Qualified Selected) the service members listed above are considered DA Selected as of the date of this message.

b. FQ-NS (Fully Qualified-Non-Select) applicants boarded for the first time are automatically enrolled on the next selection board for their respective WOMOS. These service members may also serve as alternates to fill a selected position in the event a previously selected service member is unable to attend Warrant Officer Candidate School (WOCS.) If an alternate selectee is identified to attend WOCS, the service member will be notified by USAREC G-3 Special Programs and Boards Division.

c. NS-NC (Non-Select-Non Competitive) applicants boarded for the second time and not selected incurs a 12 month waiting period prior to subsequent eligibility to compete for another board. Exceptions to the mandatory waiting period

may be considered if the service member has had a significant change to their board file. ETPs are considered utilizing USAREC Form 3.4 located at <https://recruiting.army.mil/ISO/AWOR/>. The approval for these ETPs is the USAREC G3 Special Programs Division Chief.
