- 6. All selectees must provide the following documents to the AECP Program Manager, SSG Mitchell, Richard. In order to receive orders for duty at their selected school, the documents must be provided no later than 90 days from the start date annotated on the letter of acceptance. If the selectees do not provide the documents by the suspense date, and the AECP Program Manager has not been notified of any extenuating circumstances for a delay, the select status will be forfeited.
- a. An unconditional letter of acceptance to an AECP eligible nursing school identifying the selectees report date, graduation date, and projected tuition and fees for the program categorized by semester. If the selectee anticipates the school will provide the letter less than 90 days before the designated start date, the selectee must contact the AECP Program Manager immediately.
- b. DA 2125 Report to Training Agency with the complete academic plan signed by an advisor from the same nursing school that granted unconditional acceptance. If the DA 2125 is unchanged from the application packet, notify the AECP Program Manager accordingly.
- c. DA 2125 Report to Training Agency with the complete academic plan signed by an advisor from the same nursing school that granted unconditional acceptance. If the DA 2125 is unchanged from the application packet, notify the AECP Program Manager accordingly.
- d. USAREC Form 601-37.59 AECP Contract and USAREC Form 601-37.61 AECP Statement of Understanding.
- 7. All alternates are encouraged to send their unconditional letter of acceptance as soon as possible to solidify their position on the order of merit list. Alternates that have provided an unconditional letter of acceptance will be notified by 20 May 2020 if activated from the order of merit list.
- 8. If an AECP selectee is unable to complete AECP program post-board requirements or becomes ineligible due to other factors, the soldier must notify AECP Program Manager immediately in order to forfeit their selection status.
- 9. FY 2021 applicants are encouraged to submit applications as soon as all documents are available after 1 April 2020. Application deadline to submit packets to the Health Services Program Manager is 1 Jul 2020. The FY 2021 AECP Selection Board will convene 4-6 August 2020. The AECP FY 2021 Guidelines will be published at a future

date.
